**WHEREAS**, the Douglas County Board of Commissioners recognize the substantial decrease in timber receipts from federal lands, which account for more than 50% of our land base and note that these lands are **NOT** taxable. Many factors including Congressional mandates have dramatically reduced harvest on federal lands. This has greatly diminished our capacity to adequately fund infrastructure projects as the County has in the past; and

**WHEREAS**, the Commissioners acknowledge that over the last 30 years, state and federal partners have significantly reduced funding and minimized direct access to road infrastructure grants for rural counties. Federal infrastructure dollars that are available are now sent directly to state governments, thus giving the State of Oregon sole discretion over which projects get funded, which often does not provide rural communities equal access to necessary funding; and

WHEREAS, the Commissioners note that inflation and shrinking fuel consumption has caused a reduced amount of gas tax, and combined with limited local tax bases, have required Douglas County to defer needed road improvements and routine maintenance work, resulting in a lower standard of quality for the existing road and bridge systems. Current funding levels only permit the County to maintain about 30% of the County's existing infrastructure; and

WHEREAS, the Commissioners are also aware of the Oregon legislative effort to change the long-standing 50-30-20 State Highway Fund Distribution Formula that supports Oregon's public road systems. Douglas County depends on these shared revenues to fund crucial improvements and maintain critical infrastructure that all Douglas County citizens depend on such as roads, bridges, sidewalks, bike paths, traffic signals, culverts, and fish passages. Changes to the already diminishing revenue sharing model that further reduces or eliminates the County portion of gas tax revenues, would cripple the County's ability to maintain or repair the County's aging roads and bridges; and

WHEREAS, the Commissioners also recognize the increased burden of regulatory costs associated with the growing number of State and Federal agencies that regulate the maintenance, rebuilding and construction of roads and bridges in Douglas County. Agencies including, but not limited to: U.S. Department of Transportation (DOT), Federal Highway Administration (FWHA), National Highway Traffic Safety Administration (NHTSA); U.S. Environmental Protection Agency (EPA), Army Corps of Engineers (ACE), Oregon Department of Transportation (ODOT), Oregon Department of Environmental Quality (DEQ), Department of State Lands (DSL); State Department of Forestry (ODF); Oregon Department of Fish and Wildlife (ODFW) and Oregon State Marine Board (OSMB).

**THEREFORE,** in the best interest of Douglas County and its citizens, given the proposed decrease in funding and to effectively ensure proper maintenance of County roads and bridges, the Douglas County Commissioners do hereby surrender jurisdiction to the county roads identified below and hereby return them to the absolute and complete control of the State of Oregon – Department of Transportation for all future management and maintenance.
